ZONING PART III

I ended last month's installment by mentioning that future topics would include decision making processes for zoning, building permits and appeals. Next month we will try to put all of these topics together and discuss appropriate expandability vs. overdevelopment ("McMansions"). We hope to answer the question in April why we are now seeing all of these huge houses and what, if anything can be done about it. Here goes.

Decision making process for zoning and variances

- Owner and Civics
- A home-owner dreams of and decides to enlarge his/her home.
- The owner contacts an architect (RA) or engineer (PE) to design and file plans with the Department of Buildings (DOB).
- The DOB will examine the plans to determine whether they meet the existing zoning requirements. Occasionally, the RA or PE may "professionally certify" the documents as discussed last month.

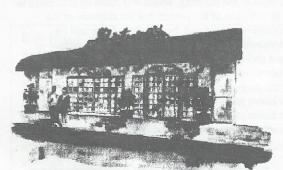

Decision making process for zoning and variances from page 1

- If the plan is self certified or DOB examiners issue a permit, the building will built or expanded without any further review or approvals.
- Civic associations and individuals will act on behalf of the community's
 interest and will carefully monitor the construction to ensure that the
 building appears consistent to local zoning. If variations appear, the
 association may file a complaint.

Community Board

The Community Boards (CBs) are city government agencies responsible to collect community opinion, represent the community's interest and advise decision makers on various issues. The CBs are an integral part of zoning. CBs help enforce zoning code by handling community complaints and serving as a sounding board on zoning-related issues. The 59 CBs participate in the official process to complete a new zone or rezoning called Urban Land Use Review Process (ULURP). CBs may propose a zone change and work with City Planning and the local community, or it may work with the community to conduct the necessary land use and environmental studies. The CB will ultimately hold a public hearing in the local area and file a formal recommendation with City Planning for zoning changes or the Board of Standards and Appeals for variances and special permits.

Board of Standards & Appeals

• While the BSA has no direct role in zoning, that Board is the ultimate decision maker on variances. The BSA resolves disputes over the zoning resolution and interpretations of the code and thus has a significant impact on future interpretation and implementation of the code. Local residents, civic organizations and other interested parties can often be found arguing their positions before

the BSA at the Board's regular Tuesday afternoon public hearings.

City Planning Department/Commission

• The CPD has staff responsible for the overall integrity of the zoning resolution and to conduct the necessary studies to ensure appropriate land use policies. The CPC is an appointed board of planners, architects, etc. with the ultimate decision-making power over zoning. Recall, however, that the Department of Buildings has the responsibility to interpret and enforce the Building Code.

City Council

 The Council has the final role to adopt any zoning change by vote of its members, but it has no responsibility in any action of the Board of Standards and Appeals. There is currently proposed legislation that would allow the Council to "call up" BSA decisions to ensure justifiability of the decision based on the facts presented.

PERSISTENCE WORKS

Thanks to the persistent work and dozens of letters and phone calls over three years by Angela and Mike Augugliaro of Queens Colony Civic Association and Rich Hellenbrecht at the community board, a bight in the neighborhood has finally been addressed. Almost everyone in Bellerose has seen the boarded up house on 249th Street near Frozen Cup. Several years ago Angela noticed that the house was being worked on and checked the permits. Angela noticed that the construction was different than what was called for in the Buildings Department permit (www.nyc.gov/buildings) and was substantially larger than approved. The owner or builder then walked off the job and left the house and lot to disrepair. Dozens of calls and letter, and the support of Senator Padavan and others to the Buildings Department were fruitless. The biggest problem was an extension out the front of the building, which was ruled by Buildings to be in violation of the permit, but the skeleton of the structure remained and the building, fence and lot deteriorated. A few weeks a go, the builder started up again and quickly on a Sunday put side walls and windows on the illegal front extension. Immediate calls by the Augugliaros resulted in inspectors responding to the house and the extension was removed. We hope that the house can now be completed and occupied and become a pleasant part of the neighborhood again.

KING KULLEN DENIES BELLEROSE SITE PLANS

Rumors have been hot and heavy about King Kullen selecting the Bellerose Lanes site for its newest store. Employees of the bowling alley have confirmed that the last day of bowling will be May 27, 2005. However, rampant rumors of a King Kullen market are incorrect. Following the lead of the Bellerose Business District, Rich Hellenbrecht, Chair of Community Board 13 called the head of real estate for the grocery retailer. The executive confirmed that indeed they had been approached about the site, but upon looking into the location and access they decided it was not an appropriate site for them. The V.P. was very positive about the area, but recognized traffic issues and proximity to the King Kullen in New Hyde Park. Other rumors have popped up about other grocery markets or retail stores, but no believable information has been received yet. The Community Board and business district will continue to investigate and hopefully report at the next meeting. We are most concerned about the loss of the bowling alley because it is among the only recreational locations nearby. In addition to individuals seeking a night out, and young couples dating, numerous leagues use Bellerose Lanes and many schools make field trips there. The nearest lanes are Strikes on Union Turnpike near Lakeville Road and another alley out on Jericho Turnpike in Mineola definitely a long walk!
