NYC agencies are prostituting NY State Traffic Laws, and selling our kids short.

The State allowed Speed Cameras in the City with the restricted use of enhancing school safety in school zones by getting drivers to slow down. While the intent of this law is noble, the reality is another story. I recently noticed one of these City run One Arm Bandits set up on Union Turnpike west of the Cross Island Parkway monitoring west bound traffic along a desolate area with no sidewalks adjacent to the traffic flow. The closest School is the Frank Padavan Campus east of the Cross Parkway. Of course the area under surveillance by the camera has no School Zone signs, and drivers exiting the Cross Island to travel west will not even pass the school. This camera is obviously not in place to protect kids, but is there to raise revenue for the City which makes this camera a violation of the law.

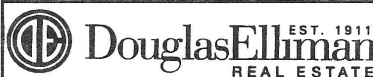

Bellerose Playground

Not much new to report here, but that Community Board 13Q has included the improvements to the playground in its 2016 Capital Budget recommendations. This budget recommendation does not guarantee inclusion in the 2016 budget, but it ensures it will at least be considered and is a priority of the board. As you know, Councilman Mark Weprin has provided \$500,000 toward the playground in his discretionary funds and Senator Tony Avella included \$250,000 for the Reading Garden area (along 249th Street). It was mentioned at the November BCCA meeting that there is a small hitch in the Councilman's funds in that it was designated as Board of Education funds rather than Parks, but we believe this will be easily resolved in the budget process.

BCCA Dues

We have been checking the BCCA Post Office Box often and after only three weeks since the distribution we have already received 190 dues envelopes. We thank our members for your quick response. We have been striving to keep our dues at only \$7 while some civics have needed to move to \$10 or more. BCCA relies in its dues to help with preparing newsletters and mailings, cover costs of meetings, including a stipend for the use of the Church hall, coffee and snacks. Dues also covers our participation in other vital organizations such as Queens Civic Congress and Bellerose Business District. No BCCA officer is paid. Our advertisers (above) payments cover most of the newsletter costs. We are extremely pleased to note that nearly half of the envelopes included some additional donation, many at \$3 or \$13, but some as high as \$50.
