Hello Bellerose. Hope all have weathered well these record breaking cold temperatures we have been experiencing, not to mention the snow that it seems has been covering Bellerose for an endless amount of time! We have been receiving more complaints with regards to our neighbors that live along 87th drive. Their yards border the ongoing construction on Jericho turnpike. Residents have complained about the noise and vibration coming from the construction site. It seems that the vibrations are causing picture frames to fall off walls and cracks to form on the homes. There is also legitimate concern that the vibrations may cause damage to foundations, beams, pipes, etc. in the homes. Our neighbors are worried. We have contacted Mark Weprin's office with regard to these issues and were told that they would look into it. We have also suggested to those homeowners effected that they should document damage to their homes caused by the vibration coming from the work site. Before and after pictures would be a good way. Also, we have suggested that a complaint be made to 311 and ensure you retain the reference

number you are given. If you feel you have major damage due to the issues explained here, you may want to contact a lawyer and be guided by them.

Richard Hellenbrecht, Lourdes Hartrick and myself have recently sat down with other civic leaders and Principal Sam Sochet at Martin Van Buren High School. The meeting was informative. Mr. Sochet seems genuinely concerned about the school and its success. We look forward to assisting him and his staff in anyway we can to ensure his and the schools success. ICCC Update

You may recall that the local five civic associations near Creedmoor each chipped in one thousand dollars to retain an attorney to coordinate and argue the community's opposition to the Indian Cultural and Community Center's proposal to build two nine story towers bordering our Bellerose community. We have thus been successful in reducing the project first to two six story apartment buildings, then to a larger four story building. BCCA and our neighboring civics remain concerned about the impact on the neighborhood, especially the adjacent single family residential Bellerose-Hillside community. We are also concerned about the precedents that would be set for the remaining acreage on Creedmoor that is now being studied by the State to be excessed and developed.

The civics recently consulted environmental experts who advised that there are several issues in the vital environmental filings made by the ICCC that may invalidate the application. The groups have agreed to chip in once again to present these findings. We will be seeking the approval of our membership in April for a \$500 BCCA participation in this effort. As a result of our initial argument the project is on hold awaiting new environmental studies. The attorney will review any new filings.

Article 5 Officers

#3 now reads: the term of office shall be one year, or until a successor is installed. No officer shall hold no more than two (2) consecutive terms in the same office.

REMOVE THE SECOND SENTENCE Should read: the term of office shall be one year, or until a successor is installed.

#4 now reads: in the event of a vacancy in the office of the President, the Vice President shall assume the office of the President.

SHOULD READ:

in the event of a vacancy in the office of the President, the Vice President shall assume the office of the President FOR THE REMAINDER OF THE LEAVING PRESIDENTS TERM AT WHICH POINT AN ELECTION WILL BE HELD IF CHALLENGED.
