
## Community Corners

Due to the importance of the subject, most of this issue will be devoted to the bus problem:

Buses, buses and more buses! Apparently we have been chosen to receive what other areas do not want in their backyards. Our area is faced with a serious problem of utilizing residential steets for bus feter routes. We have made our opposition to the use of our streets known to all our elected officials and representatives of the transit authority. There have been many meetings held regarding this problem without any acceptable alternatives being developed.

Presently, all of the Q43 and Q44 buses will continue to use Commonwealth Blvd. in a north bound direction. The only alternative proposed to date is to remove the hill at Jamaica Ave. and Little Neck Parkway and route the Q43 on Little Neck. This plan has also

received opposition from our property owners along this route. The Q44A would be routed east on Jamaica Avenue to Lakeville Road. However, both of these plans seem to be in the distant future.

The use of the Cross Island Parkway has also been proposed but we are faced with the requirements for state legislature approval, the completion of traffic and feasibility studies and considerable opposition from those property owners along the Parkway and the Creedmoor Civic Association.

Our Association supports the position of no use of our residential streets. realize that this is an extremely hard line but feel that if a compromise finally results, we prefer to compromise from a strong position. Also, the actions and demonstrations by many of our home owners has also been very helpful in providing visual evidence to the various authorities that we do not intend to meekly give in.

There are many who feel that this issue has caused serious division among various civic leaders. One would have to be extremely naive not to anticipate a division of reaction on such an emotional issue.


