Hello Bellerose,

Its official—on June 24, 2013 the long-awaited rezoning of Bellerose and Floral Park is official. The new map are posted at www.nyc.gov/dcp. As of that date our area is further protected from overdevelopment by large "McMansions," and only single family homes can be developed in the area, except some parts west of the Cross Island Parkway near Braddock Avenue. Several projects underway or about to start have been stopped, Be aware that most of our homes in the BCCA area were underdeveloped and can be expanded somewhat, even under the new regulations, but the size and shape have been limited by the technical features of the zone. We thank Councilman Mark Weprin and Senator Tony Avella, both of whom have been tremendously helpful over the last decade or more to get this project going. We also thank our neighboring civic associations-Queens Colony, North Bellerose, Bellerose Hillside, Creedmoor, Lost Community, Oueens Village and Glen Oaks Village Owners. BCCA as part of this group of civics has been working together for many years to protect our area and keep it great. Our efforts also resulted in the return of the Little Neck Parkway bus (Q36 extension), upgrade of Jericho Turnpike, etc. Those of you who attend our monthly meetings know that we are often visited by presidents of those organizations and we frequently visit their meetings.

The September meeting will feature a representative of the Department of Environmental Protection. They are responsible for water supply and sewers. We will get more information on the new water main and sewer protection program. For a monthly charge of under \$15 on your water bill you will be protected from the costs of any street-side water main or sewer break. Many of you know that these repairs can cost up to \$15,000 or more. A neighbor has already used the program and was extremely satisfied with the service and it cost nothing over the monthly charge. Come and get the details. BCCA would like to thank Gertrude Helga for handling hospitality at our meetings. She has been terrific in bringing milk, cakes and cookies, setting up for the meeting and cleaning up the kitchen, with some help from others. Due to change in work schedule, Gertrude is no longer available. We are seeking a volunteer for this important responsibility. Of course we pick up all costs and members are helpful. Please come 9/5 and let us know.

ICCC Plans Apartment Towers In Creedmoor

The Indian Cultural and Community Center (ICCC) has renewed its fight to build two nine story apartment towers immediately adjacent to the Bellerose Community near Union Turnpike. You may recall that this came up two years ago after the ICCC amassed several acres of land on a commercially zoned area previously used by Creedmoor Psychiatric Center for automobile and truck parking and maintenance. Under New York City zoning regulations residential construction is not permitted in a commercial zone. Regulations also require frontage on a city street for construction to proceed. The ICCC site does not have any frontage and is seeking a dual variance from the Board of Standards and Appeals to allow the residential construction and for the use of internal Creedmoor roadways to access the site.

ICCCs initial plans divulged to Community Board 13 and local civics called for merely a one-story community center and recreational field with parking. This initial plan was well received and embraced by the community. After several years lapse ICCC came forward with a bold plan to instead build two nine-story apartment towers in violation of existing zoning regulations and within 30 feet of the back yards of one and two story single family homes. The apartments were described as assisted living type residences for senior citizens, allowing for children to live with them. While the group stated the center would be open to all, it later came out that the group had raised money by in effect selling the future apartments to its members.

The various civic associations of Bellerose and Glen Oaks joined together in opposition to the construction of such an imposing structure so close to low rise private houses and we were successful in getting the community board and borough president to oppose it. State investigations were launched into to the no-bid, less than market rate purchase price, and the project was again paused.

We have now received notice that the group is now seeking to proceed. The Board of Standards and Appeals (BSA) is the authority to grant variances. BSA has scheduled a public hearing on September 10 at 10:00am at 22 Reade Street in Manhattan on both the commercial variance and the waiver for street frontage. Our civics support open, areacompatible senior housing as we did at Fr. Reader Senior Housing opposite the YMCA. But we remain adamantly opposed to a high rise development in our area.
