

#### 100% ASSESSMENT

A rally to protest 100% assessment of our homes was held October 18th at Martin Van Buren High School. One point was saliently made: it is up to us to stop the reassessment.

The average increase for homes in Queens will be 138%, or \$1,292 per home. Added to my present real estate tax, it will give me a \$1,957 real estate tax bill. While we, the homeowners, are struggling to pay this increase, the commercial, industrial and utility classes will have decreases in their real estate taxes. Do you think its fair that Con Edison and New York Telephone will be paying 23% less in real estate taxes, while we pay 103% more? New York State and New York City will not be receiving any increase in tax revenues -- the burden of taxation will simply shift from the business classes to us.

Assemblyman John Esposito introduced a bill in the Assembly to repeal Section 306 of the Real Property Tax Law. His bill (#6136) calls for retention of the present system of tax assessment for New York City. It would give other local governments in the State the right to their own property tax assessment system.

We must let the politicians know that we support Assemblyman Esposito's bill. We must let them know that we elected them, and that we will not re-elect them if something is not done to halt 100% reassessment. The politicians have assured us that they will safeguard our interests. They will implement tax credits and "circuit breakers" (tax rate based upon taxpayer's income) to ease the tax burden. One of the speakers at the rally put it very succinctly: "Giving money to politicians is like giving heroin to a drug addict."

By order of Mayor Edward Koch, reassessment has already begun in New York City. This reassessment process will cost taxpayers \$30,000,000 statewide. Assemblyman Esposito's bill must become law before the 1980 primaries, when politicians will certainly take up the torch to make reassessment a political issue. By then enough homes will be reassessed to make the higher assessment the majority. It will be too late.

We must contact our elected officials to demand that the Esposito bill be passed into law. Please let your voice be heard -- don't let Queens become a wasteland.
