## Merchants' Survey

The BCCA is cooperating in a survey which is being conducted among the various merchants along Jamaica Avenue/Jericho Turnpike from just west of the Cross Island Parkway east to the city line.

Since many businesses have left the area and left behind vacant and unkempt buildings, the purpose of the survey is to try to identify factors the entrepreneurs use to locate or stay in Bellerose. Hopefully, if these factors can be identified, we can encourage firms to stay or attract new firms to fill in some of the vacancies. An additional desire is to encourage the business owners to work together more closely to take care of any problems that discourage business growth - like graffiti, parking problems, litter, etc.

We are working in concert with our neighbors, the Queens Colony Civic Association, as well as the Bellerose Village Business District Development Council and the Bellerose Terrace Civic Association in Nassau.

So far this is an effort of real cooperation between Queens and Nassau civics and businesses. The surveys will be compiled by the next Action News and we will report further in January.

## Queens Village Bus Depot

The New York City Department of Transportation, while speaking in front of a Queens Village area civic association, made a suggestion that the informal bus depot located at the dairy/deli/Duncan Donuts on Hillside Avenue and Springfield Avenue should be removed.

Buses leave from this location to the casinos in Atlantic City and Foxwood and to all locations throughout the United States. Without this depot, most of us would need to go far out to Nassau County or travel to the Bus Terminal in midtown Manhattan to get our children back to college or meet other visiting relatives. Most civies in Queens Village and east have indicated a strong desire to keep the bus depot. Let us know what you think.


