

This applies to New York City residents of 65 years and over, and you must submit proof of age such as driver's license, passport or birth certificate (MEDICARE card not acceptable). To be eligible you cannot be employed more than 20 hours a week, and don't forget to bring your Social Security number. Your transit card will be mailed to you within ten days to two weeks after processing of application.

The next time you are in the Library, apply for your new permanent computerized card. This is for systemwide membership at any branch of the Queens Borough Public Library. QBPL is the first library system in New York City to be computerized. It is the 5th largest library system in the country (NY, Chicago, Los Angeles, Brooklyn).

FALSE ADVERTISING REALITY

It was brought to my attention by a member of our association recently that her home was photographed, without permission, and the photograph inserted on the window of a local real estate office stating, "This Beautiful House North of Hillside Avenue Won't Last".

When questioned by her neighbors about the sale of her home, she learned about this photograph.

We have called Senator Frank Padavan's office and given him the details since we believe this is an unethical business practice and should be stopped.

While walking through our community last week-end after the snowfall, we were pleasantly surprised by the civic pride of the home owners in our area. Most of the sidewalks were shoveled; however a few were untouched. Perhaps we should list the house numbers in the future if our neighbors do not clear their sidewalks.

We wish to point out that it is illegal to push snow into the crosswalks and into the middle of the street. Please throw snow on your lawn or the strips along your curb. This is one of the most beautiful areas of Queens - let's keep it that way!

DOUBLE YOUR TAX????

Mayor Koch said that he was going to have all real property assessed at 100% of market value, but that he, in no way, wished to change or imply a change in the real estate tax of one and two-family homes in New York City. This was in reply to a letter from Senator Padavan who strongly criticized the Koch order which panicked middle income and senior citizen homeowners in Queens. Koch assured Padavan that the order was intended to preserve the existing assessment system while the city takes inventory of its real estate stock. "We are also concerned with the individual homeowner and senior citizen" Koch wrote. . . "and will not permit the imposition of any destructive type real property tax action."

As a property owner, I am very skeptical about such promises by our Mayor, who thinks Queens ends at Forest Hills. All politicians who live in Manhattan believe our area is "somewhere out there in New York State" and not a part of New York City.

I suggest we invite a representative from the Real Estate
Tax Department and Senator
Padavan to a future meeting
so that we may thoroughly
discuss this matter.
