

### **Queens Civics Fight Illegal Conversions**

I would like to commend two neighbor civic associations: the Creedmoor Civic Association and Rocky Hill Civic Association for their efforts to stop local real estate brokers from illegally selling houses on the basis of potential second income.

Recently Rick Duskewitz and Bernard Aquilino visited an open house to see what brokers were telling prospective buyers about the houses they were selling. In one visit a broker, knowing about the one-family zoning, told Rick and Barney that renting out a basement apartment could offset the monthly mortgage expense. When they asked if the celler apartment was legal, the agent replied that "the apartment was not legal, but that people in the area don't care."

All of the local civics strongly oppose illegal apartments and ask that homeowners report any suspicious construction, multiple doorbells, extraordinary amounts of garbage, frequent comings and goings, etc. Any apartments in most Bellerose houses are not only illegal, but they also impact the quality of life for the surrounding neighbors and create unsafe living conditions for everyone living in the house. I can not over emphasize the importance of this blight on our area. every month we write or make calls to seek investigation of some local house. Don't let brokers or buyers think we don't care.
