## **New York State Flyer Law**

Rick Duskiewicz of the Creedmoor Civic Association has informed the BCCA of a state law that was signed by Governor Pataki on July 29th. The law says it is now illegal to place flyers on windshields or windshield wipers. Similar to the public pole posting law, the company whose phone number or address is on the flyer is held responsible.

**Absentee Landlord Surcharge-**A lot has been written regarding the Absentee Landlord Surcharge that is being imposed by New York City Department of Finance. This is a property tax increase on Class 1 properties that are not owner-occupied and that generate rental income for the owner. If your property is your primary residence you may need to submit a petition to be excluded from this surcharge. You may also be entitled to a property tax reduction under the NY State STAR program. If you are already enrolled in STAR this will not an issue. If you are not in STAR you may need to submit a form to be excluded from the absentee landlord surcharge form. You can enroll in STAR online at www.nyc.gov/STAR. Look up www.nyc.gov/propertytaxes or contact 311 for additional info. Forms will be available at the November 6th BCCA meeting.


