

LITTLE NECK PKWY TRAFFIC CONTROL

Thanks to constant follow up by our Council-a job well done and my man and others, we've finally gotten positive response from the City Department of Transportation. In reply to at least part of our request the city will install signs barring trucking on the parkway and will scarify (cut roadway grooves at curves to prevent hydroplaning) the roadway surface as we suggested. In addition, some improved markings will be installed to warn of the curbs. Data is being collected relative to the requested traffic light at 86th or 87th Ave. Stay tuned.

PAVED STREETS

In the spring, Bob Costagliola, assisted by other board members, BCCA members and a local Boy Scout Troop, completed a comprehensive street survey of the BCCA area. The group's report was sent through our local legislators and Community Board to the various city and state agencies for correction of the problems. Thanks to a very well put together report and significant support particularly from Councilman Sheldon Leffler and Senator Frank Padavan, the response has been quick and encouraging. You will notice that strip paving has been accomplished on Commonwealth Blvd. and other patch paving has been accomplished throughout the neighborhood. Our roads are being reviewed by the city for possible

major capital replacement in a few years. My commendation to Bob and his group for appreciation to the Senator and Councilman for their assistance.

CROSS ISLAND PKWY/ HILLSIDE AVENUE OVERPASS

Biennial inspections by both consultants and city inspectors revealed that the Hillside Ave. Overpass over Cross Island Pkwy. had a cracked wearing slab. Part of the north stone parapet wall was missing and sidewalks and curbs had settled and were badly deteriorated.

To prevent further deterioration due to the effects of salt, water and frost action, the N.Y.C. Dept. of Transportation had a private contractor begin rehabilitation in July. Work includes replacement of the concrete sidewalks and roadway and replacement of street light and traffic signal foundations.

An engineering consultant for the contracting firm recently advised us that the project should be completed on time, by the Alend of the year. though originally estimated at \$947,000, it appears that the work will cost the city (and us taxpayers) slightly less than three-quarters of a million dollars.

P.S. 133 PARK HOUSE

Should the brick park house in the playground behind P.S. 133 be removed? That suggestion was made recently due to the vandalism to the building. Though closed for years, the interior has been damaged by youth whose bolt cutters are not thwarted by Parks Dept. padlocks. The exterior has been painted and touched up many times, thanks to the untiring efforts of one of our members.

A park house brings back memories, to many of us, of the "parkee", the Parks Dept. employee once assigned to each park, and the games and other playground equipment he stored in the park house. To some of us it brings back pleasant memories of Mrs. Salter and the Parks Dept. pre-school program not so many years ago at our playground. Even now, the larger park house at Braddock Park is used for a preschool program and efforts are being made to have that facility enlarged.

But what about "our" park house? If it's leveled now, and the city's fiscal situation becomes better, would the chances of having a new park house constructed be remote? Can the entrances be blocked up or otherwise made secure for possible future use in better times? Should the building be completely removed?

Let us know your feelings. Community Board #13 (219-41 Jamaica Ave., 464-9700) will hold a public hearing on the matter at the beginning (approximately 8 PM) of its October 22nd meeting. Here's your chance to be heard.
