New District Boundaries

The summer has dealt a cruel blow to the various communities of Bellerose. In keeping with a governmental mandate to increase the power of minorities, parts of Bellerose have been carved up and added to different district. Our area was added to District 33, anchored on the south side of eastern Queens and represented by incumbent Barbara Clarke, a Democrat from Cambria Heights.

Our previous assembly district and incumbent Assemblyman Doug Prescott are now miles from here in Flushing. Our Senatorial District changed slightly, but Senator Padavan still represents our area. On the Federal front, Congressman Ackerman, who reporesented us for several years is no longer in our district. We will now be part of Congressman Floyd Flake's 6th district.

In this very busy election season, all three positions are up for election. While Senator Padavan's strong hold in this areawill easily carry him through, there will be tough battles for Assembly and Congress.

The State legislators in gerrymandering this area butchered parts of Bellerose, going so far as to cut a neighboring civic association (Bellerose Hillside C.A.) in half. All of our civics argued vehemently earlier this year against breaking up our north central Queens area by making Jamaica Avenue the southern boundary. But politics won out. Casting our neighborhood into an area that is heavily weighted miles south of us will substantially weaken our access to political power and influence and may affect our quality of life.

It is very hard to keep any discussion from sounding racist, but in fact, the State's redistricting committee cleasrly speaks of its mandate to empower minority communities, voters and candidates. In this case, the empowerment clearly disenfranchises this area. Our new district is 65 percent black and 85 percent minority in total. Its current incumbent, who is black, represents a solidly black area and is not concerned about Bellerose. It is unlikely

that our town will ever be a major political interest for an official with a such a solid majority.

October's Candidates Night will be critically important to ensure that we have a voice in our new district. We will need an IN-CREDIBLE turnout to make a serious impression. I understand that a local civic president, Richard Cannon of the Bellerose Hillside C.A. is running for the Assembly seat. Please pay close attention to this election, and by all means VOTE.

Register to Vote

It is more important than ever for everyone in our area to vote in this Primary and general election.

I will have voters registration cards at the September and October meetings. Please try to get every relative and friend who is eligible to register and vote in the September 15 Primary and on November 3.

Roadwork Finishing

As we go to press, the reconstruction of the Cross Island Parkway northbound side has been completed and finalization of the southbound side is underway. I have asked Albert Wong, Project Engineer to come to the September meeting and brief us on what we can expect for the duration of the project.

It is already hard to remember the condition of the short

entry lane we lived with on the northboundentrance. The interim staging ramp was very dangerous and we are glad there were no serious accidents during construction.

At press time, the southbound reconstruction has caused the pedestrian underpass to be closed for removal of the retaining wall. We are advised that this has been timed to ensure that the underpass will be open

for the first day of school at St. Gregory's and P.S. 133.

Also at press time we were surprised to notice a major resurfacing on Little Neck Parkway. Although this roadway was recently reconstructed, a number of cracks opened up. Several local residents have written to our elected officials and gotten quick action to correct these problems. It pays to complain.

Once again the peace and quiet of Bellerose was shattered at 11:30 pm on July 4. At that time a volley of nine semi-automatic shots rang out from the rear courtyard of PS133. Upon investigation the next morning, several of these shots went through one of the back doors and caused damage to the metal door and woodwork inside the school.

This event was very disturbing since it had been several months since the last gunshots were reported. We had hoped that whomever was responsible either left the area, got arrested.

Principal Mazer was very upset and contacted the 105th Precinct. Officers from the precinct came to inspect the damage to the school and got some leads from community members about the perpetrators. They will continue to monitor the park.

Potholes

Due to a backlog of 25,000 potholes throughout the city, City Hall allocated \$400,000 worth of overtime work for 60 crews on three Saturdays(August 22 to Sept. 5) to catch up. Sixteen crews, the largest contingent in the City, were sent to Queens.

This program is an attempt to be more responsive to pothole complaints. Thoroughfares in need of major resurfacing will be done at a later date.

Be prepared for a smoother ride if you venture into some of the more pockmarked areas of Queens and other boroughs.

Sewer Bills

Our new Congressman, Floyd Flake, has notified me that many complaints have been received about exorbitant and unexplained sewer bills. Apparently the charges relate to conversion to metered billing, which has not yet affected our area. The City has sent large bills for the conversion to residents without explanation, and has added an 18% interest for the remaining balance until the entire amount is paid. Occasionally residents have been billed and paid sewer taxes continuously, but for prior periods. They are then billed for current balances.

Under a plan adopted as a

result of Rep. Flake's intervention, the delinquent charge has been cut to 9% and DEP devised a split-bill plan to reduce the impact of these increases. Tax payers billed at 50% more than the prior bill may request a split-bill. An initial payment will be made and the balance rebilled in three months with no interest.


