Worried about our Gas Mains?

Just about every block in Bellerose seems to be continuously attacked by Con Edison crews punching holes in the tarmac and leaving piles of dirt for days. Later, they refill the holes and after a few days place several layers of substrata and finally pave over. But you can see the patch for years to come.

Quite often this work seems to be done as a result of complaints of gas odors. Did you every wonder about how safe our area is? Did you ever wonder if it might be cheaper and smarter if this work was done to the entire area on a planned basis?

Well, now is your chance to ask. While you're at it, its time to ask about other energy-related things, like the cost of gas and electricity, deregulation, conservation measures for your home, the recent replacement of gas regulators, etc.

Most importantly, find out about how our area may be affected by energy shortages such as California is going through. Will we be subject to rolling brownouts, or even blackouts? What is the best way to prepare our homes and families? How can we conserve to reduce the problem?

Hellenbrecht Elected Community Board Chair

In July, BCCA President Richard Hellenbrecht was elected by Queens Community Board 13 as Chairman of the Board. Rich has been President of BCCA since approximately 1985 with the exception of a few years when Richard Brown and Joseph Byrne took over in the mid-1990s.

As Chairman, Rich will be responsible for the delivery of city services throughout the CB13 area, which runs from

the Grand Central Parkway to Kennedy airport and consists of over 177,000 residents. The Board acts on all major land use proposals, advises the City on capital and expense budget items for the district and handles community complaints. CB13 is strengthening complaint processing and follow up. Please notify CB13 at 464-9700 of any complaints with city agencies or utilities. Staff at the office will notify the agency, copy you on the complaint and follow up in a reasonable period.

Rich Hellenbrecht also represents the BCCA on the Queens Civic Congress, where he is a Vice President. Queens Civic Congress is a boroughwide cooperative of over 100 civic organizations. The Congress has made great strides in boroughwide and local issues. For example, the Congress wrote a plan for the Creed-

Illegal Conversions & Other Building

The most serious problem facing Bellerose is the proliferation of illegally converting one-family houses to two or more families or to single occupancy units. On most blocks there are at least a few converted houses, affecting parking, crowding schools, increasing garbage, etc.

As we've stated over and over again, our part of Bellerose is zoned exclusively for one family houses. You MAY NOT LEGALLY CONVERT YOUR HOME to two families or "mother/daughter" use in this zone NO MATTER WHAT YOUR REAL ESTATE BROKER MAY TELL YOU. Note that some two-family buildings pre-existed the 1961 zoning resolution and are legally grandfathered.

Many houses are now being expanded to raise the second floor, particularly cape cods. Any proposed expansion will require a

building permit. Furthermore, any major interior work—removing walls, moving stairways, major changes to window openings—also require building permits. Ideally, the building permit review will identify violations of the zoning code. But many times they let things through and a minor change after inspections results in a two family building.

Legally expanded houses are greatly improve our area and increase the value of your home. We support legal expansions. But conversions cause irreparable damage to our community. If you are thinking about it—please don't. If you know of any, please respond to our P.O. box with an exact address and some evidence (what you see). We would like your name for our confirmation, but we can withhold your name if you want.


