#### Frank LoCicero is Honored-

The triangle of Hillside Avenue and the southbound Cross Island Parkway Service Road has been dedicated to Mr. Frank LoC icero, who died in November of 1997. Mr. LoCicero was a longtime civic leader and was President of the Bellerose-Hillside Civic Association for more than 20 years. He was most recognized for organizing demonstrations against a city proposal to put sanitation garages near residents at the Creedmoor Psychiatric Center. He proposed alternate sites for the garages, which were used to store and fix garbage trucks. The city decided to build the garages near the Cross Island Parkway, farther away from the residents. He also volunteered at the Queens County Farm Museum and at the VA Hospital in Manhattan. Councilmember David Weprin presented LoCicero's family with a "Frank P. LoCicero Triangle" sign identical to the one that was placed in the soil of the triangle. It is an honor that is well deserved for someone who served and represented our neighborhood.

## Firefighter Robert King Jr-September 11th Hero is Honored

249th Street and Superior Road was named for Firefighter Robert King, Jr who died on September 11th 2001 at the World Trade Center. Our prayers go out to Mr. King's family. On this second year anniversary of the September 11th tragedy, we should take the time to remember those heroes like Mr. King, who sacrificed their lives to help others in danger. In addition, we should also remember those innocent victims who lost their lives.




